VOTED: Motion of Roger Woods, seconded by Chris Primiano, to set the Residential Factor to 1 resulting in the same tax rates for Commercial and Residential Property of less than or equal to \$0.50 per thousand dollars of property values.

VOTED: Motion of Roger Woods, seconded by Kelli O'Brien-McKinnon, to raise and appropriate \$28,900 from additional Pledged Revenue and increase that revenue source and the offsetting Debt line item both to \$1,175,000.
